The nominal amount is repaid at 100% if the EURO STOXX 50® index always quotes above the barrier of 49% of its starting value during the term. Issuer Risk:

As a bearer bond, a certificate is not subject to Austria's deposit protection. What You Should Consider Before the Purchase of Bonusové certifikáty:
