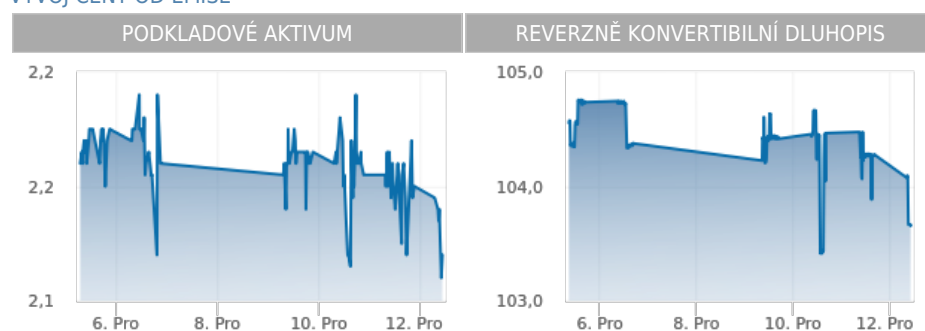

What You Should Consider Before the Purchase:
