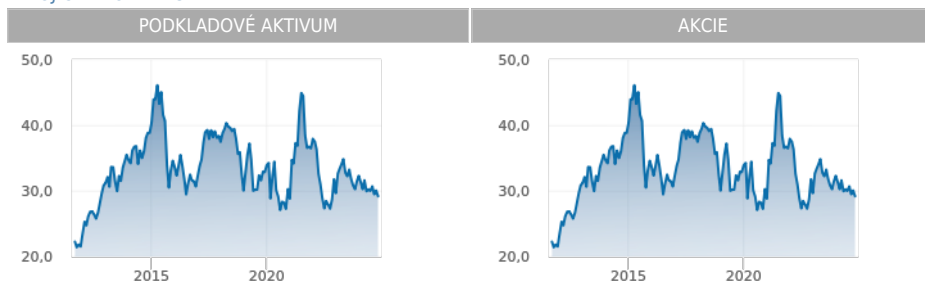
#### POPIS

Types of Reverse Convertible Bonds are Protect Reverse Convertible Bonds and Plus+ Protect Reverse Convertible Bonds.

### Issuer Risk:

## What You Should Consider Before the Purchase of Reverzně konvertibilní dluhopisy:
