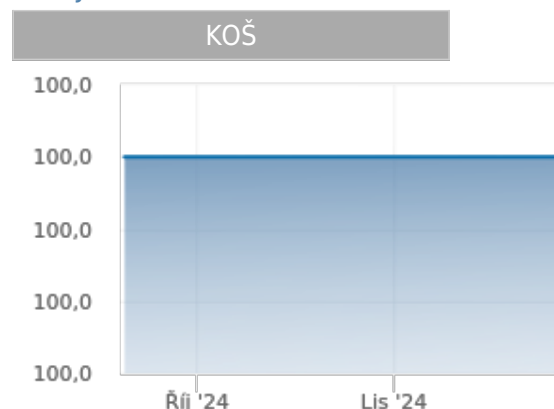

POPIS
