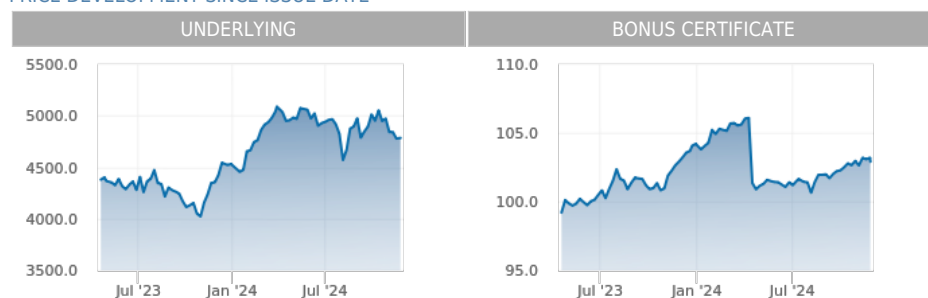

DESCRIPTION

With the certificate **Europe Inflation Bonus&Safety 17** investors receive an annual interest rate consisting of two components: 2.4% fixed interest rate plus the euro area inflation rate. The nominal amount is repaid at 100% if the EURO STOXX 50® index always quotes above the barrier of 49% of its starting value during the term. In the event of a barrier violation, investors are exposed to market risk on a one-to-one basis. In this case, a substantial capital loss is possible.

Issuer Risk:

As a bearer bond, a certificate is not subject to Austria's deposit protection. What You Should Consider Before the Purchase of Bonus Certificates:

- **Barrier event:** If the barrier of the Bonus Certificate is touched or undercut during the term, the protection mechanism is suspended.
