### Issuer Risk:

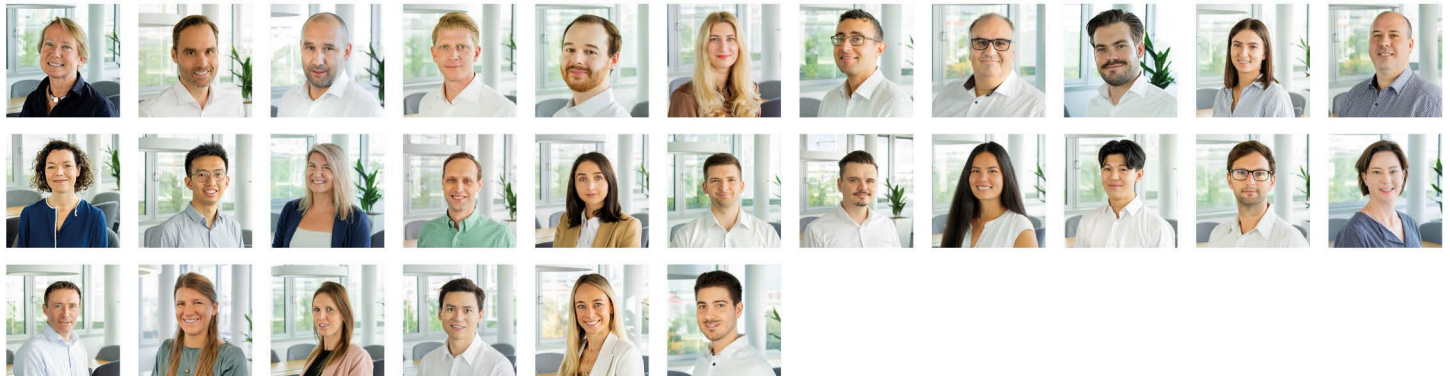
