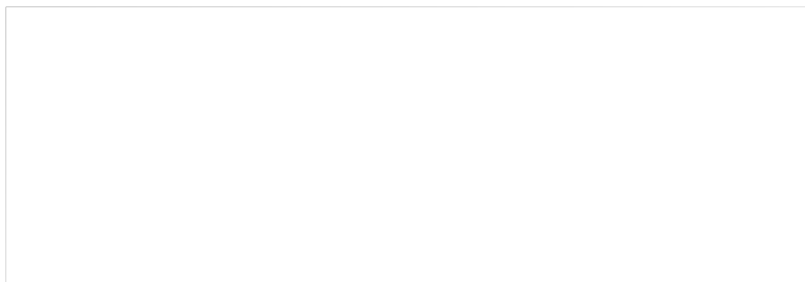

### The Certificate

In case of a negative gold price performance at the end of the term (from the starting value to the LBMA Gold Afternoon Fixing Price at the final valuation date), the investment is 100% capital protected at the maturity date.
