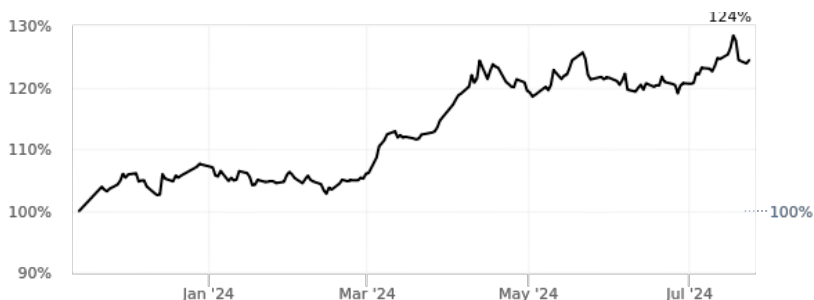

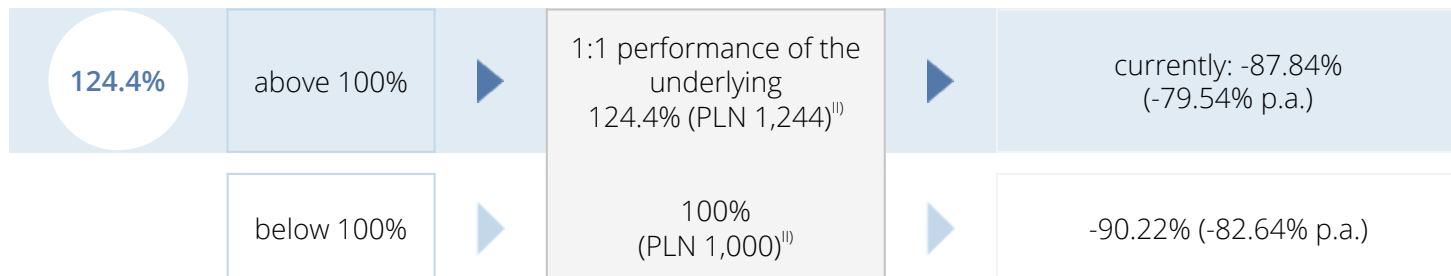

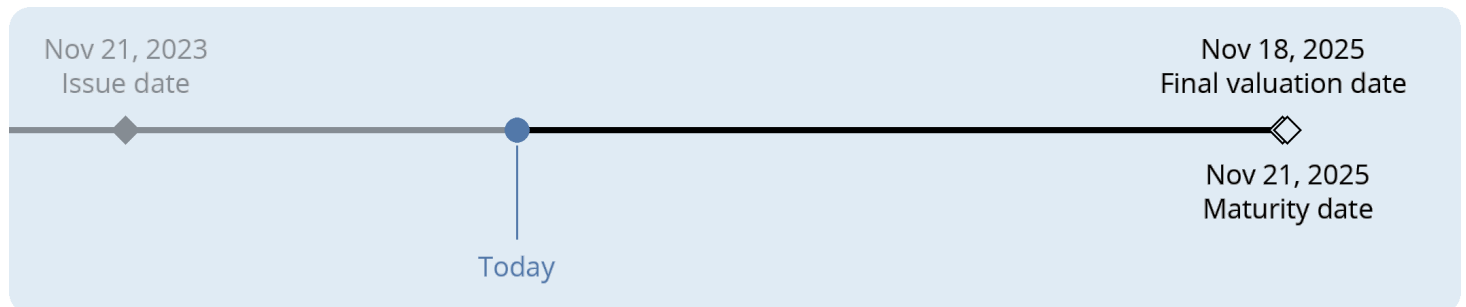
The Certificate
