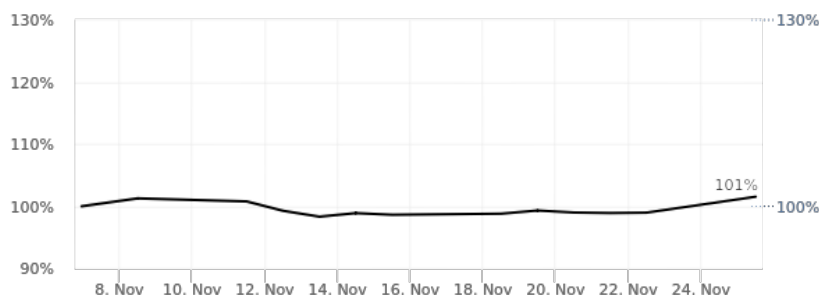

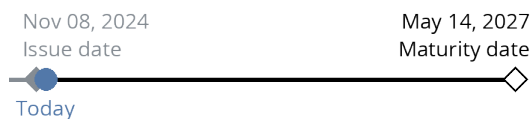

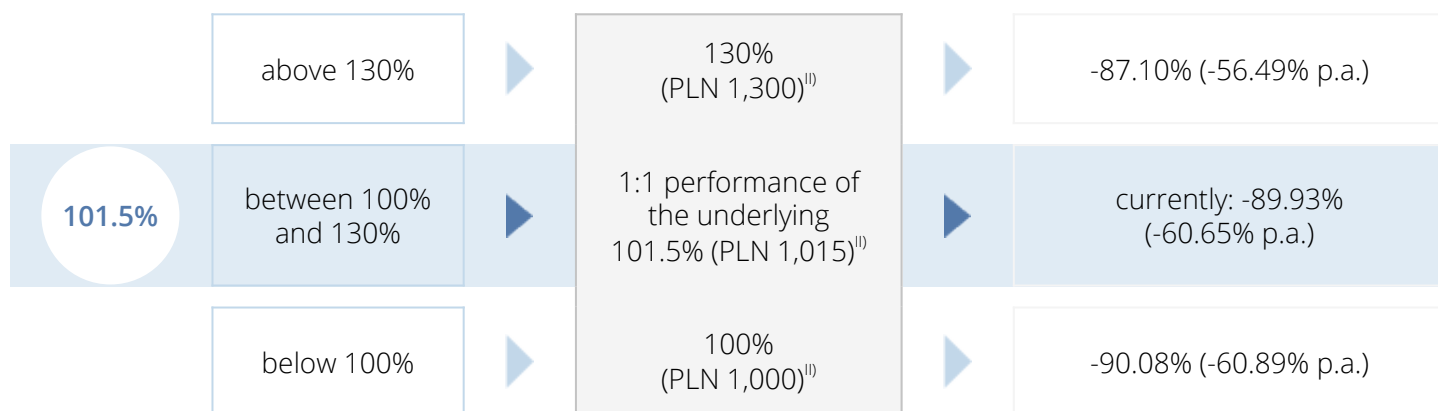

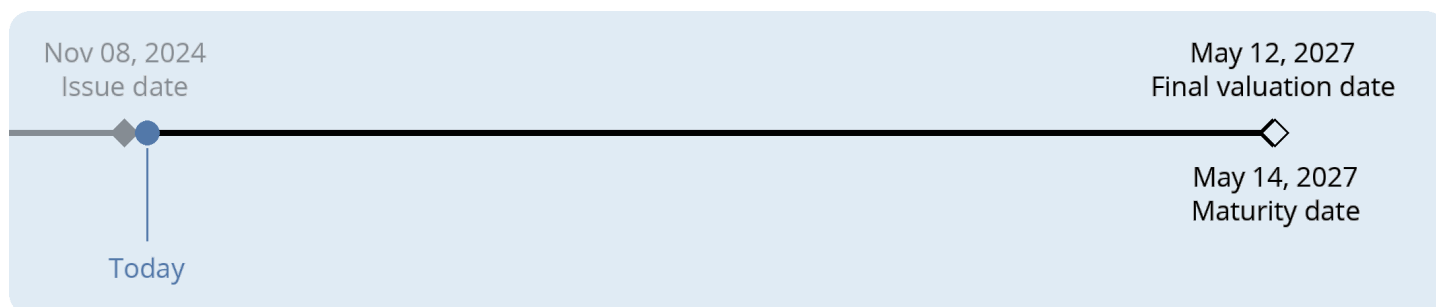
The Certificate

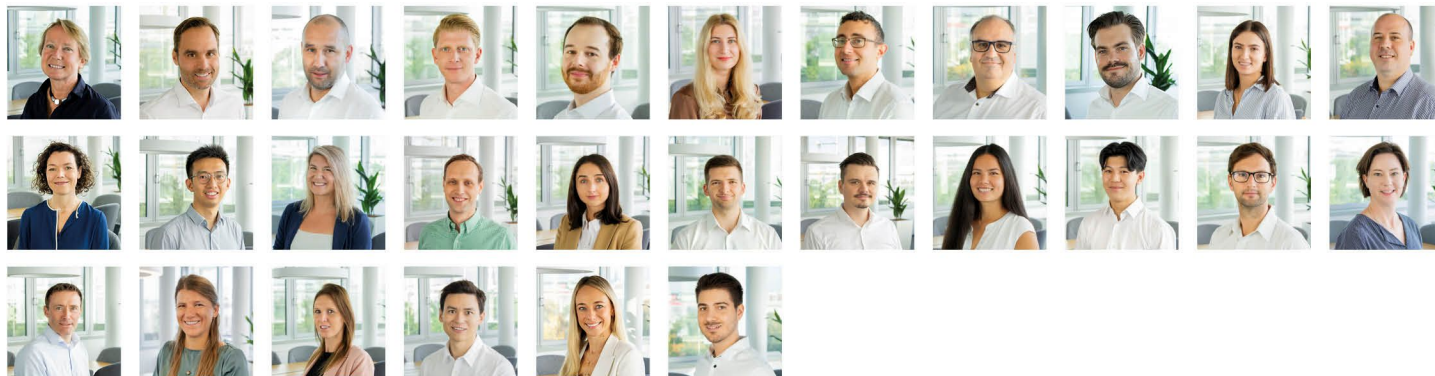
