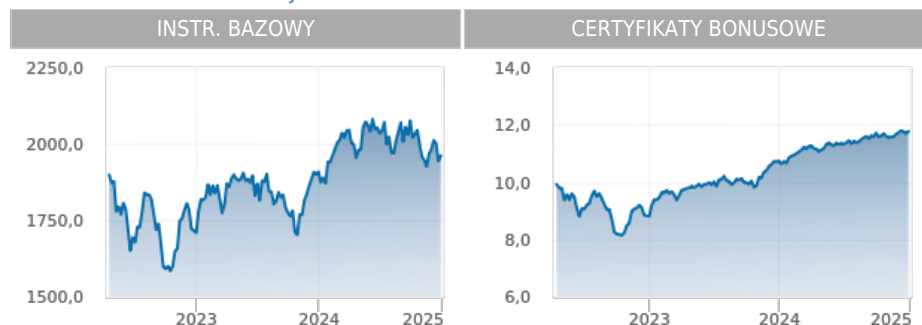
OPIS
